<u>Issues Related To Contracting Based On Room Nights</u>

I am aware that contracting with a hotel for a set number of rooms has been an issue in the past. I do not think this should be an issue with this proposal. There are a number of differences between this proposal and the event that was an issue in the past.

- 1. The room rates that are being proposed are about \$20 less per night than some past 12th Nights.
- 2. The contracted number of rooms will be less then half the amount originally contracted for at the 12th Night in Seattle.
- **3.** We plan to begin advertising the event as soon as it has been approved. We will focus part of our advertising on why people from the local area should rent a room for the event.
- **4.** 200 rooms rented per night at quad occupancy would house 800 people. That is 400 less people then the project amount expected to attend the event.

Below are the different cost breakdowns if the minimum room nights were not met. I am positive that we will be able to book 400 room nights and yet I wanted to show what the costs would be if we did not.
